The spectroscopic method of phase coherence used to produce this report was verified in blind testing of 8 samples within one of the University of Kassel projects (Report No. 112/2009 of 30 November 2009). The databases used to interpret the results have an empirical basis which is recognized at individual points only in terms of university science. Statements in this area may in no way be construed as medical or pharmacological ones or as a promise of therapeutic effect.

1 Subject of examination

The «Somavedic Medic Uran» devices has been introduced on the market by Somavedic Technologies s.r.o. As a stronger version of the "Somavedic Medic" device. A request has been made to prolong the certificate for this product issued by IIREC. Preliminary assessment of the request shown that the following relevant changes in quality occurred:

 The unit body is now made of crystal with admixture of uranium instead of opal glass.

To prolong the certificate, it was therefore necessary to check whether the previously found effects of the unit (report No. 11/2015), i.e.

- 1. improving the environment in magnetic fields with geopathic burden,
- 2. improving the environment in magnetic fields of technical devices (iPhone),
- 3. and creating biologically beneficial signal spectre of water, especially in relation to defence against pathogenic germs and other parasites, remain the same.

After these items have been verified, the following tests have been carried out.

A specimen sent by the producer was used as the **test unit**. The device was always connected to the mains and exposed to the magnetically measured field or under a sample of water the spectre of which was to be analysed.

The space above a geological anomaly (deformation) and a relatively uniform background for the operation of a smart phone (iPhone) were used as the **test areas for the exposure of the damaged magnetic field**. Both the areas were located on the ground floor of the Institute. A wooden measuring grid with punched holes (11x11 measurement points) were used as the measuring field. For the details of the measuring process, see the report No. 11/2015.

2 Examination of the effects in the magnetic field

From the biological point of view, the magnetic field is particularly important because it permeates our body,

cannot be significantly shielded, affects all life processes and directly affects particularly the ions, electrically charged particles in the body (e.g. sodium, potassium, calcium, magnesium, zinc and many others in our cells, iron in the red blood pigment, etc.). Also, the signals contained in our intracellular and bodily fluids are magnetic in nature.

Examination in the magnetic field is therefore the first choice when testing coherent action of resonant products. (Coherence in physics means a firm relationship of phases between the oscillations of several individual elements. Coherence is therefore a principle which leverages microscopic effects, e.g. causing normal light become laser light.)

2.1 Methods of measurement and evaluation

Unlike for the previous expert opinion, an improved Teslameter FM 302 made by ProjektElektronik (Berlin) was used for the measurements. The most important technical data are summarized in the following table:

2.2 Test in a geopathic field

The individual steps and the results of this range of measurements are described in detail in Annex 1.

2.3 Test in a technically disturbed field (iPhone)

This range of measurements is described in detail in Annex 2.

3 Effect on water

The process of preparation of the water sample treated with the specimen unit and of the measurements of signals instilled in water, compared with an untreated reference sample, are described in detail in the report No. 11/2015.

3.1 Methods of measurement and evaluation

Unlike for the previous expert opinion (report No. 11/2015), the measurements of signals instilled in water was not carried out in two steps at (+) and (-) circular polarization of an impulse, but in one step at simultaneous +/- circular polarization which enabled a simultaneous recording of resonances with both a positive (+) and a negative (-) sign of the signal.

3.3 Results and their evaluation

Spectres of the sample treated with the products and of the untreated reference sample are shown in Annex 3. Using the results of treating with

- of a sample treated with Somavedic Medic Uran,
- of a sample treated with a Somavedic Medic unit (current version) tested in the same way, and
- of the previous version of the Somavedic Medic unit,

- their biological impact.

4 Expert Opinion

This part contains expert evaluation of the product based on the terms and conditions for granting the IIREC Seal. This expert opinion is based on chapter 2 and measurements in DC and ELF magnetic fields, as depicted in Annexes 1 and 2.

Assessment materials are available in the previous expert opinion No. 11/2015 in detail.

4.1 Metrological relevance of measurement results

Effects established during measurement - first, disturbing effect of the measurement field due to various causes (geological, technical); second, changes achieved after locating the unit in the test field of a scope that exceeds measurement uncertainty and thus can be evaluated as **significant**. This is expressly noted in Annexes 1 and 2.

In the magnetic field damaged both with geopathy and technical devices, the tested sample of the Somavedic Medic Uran current version has proven usable for equalizing these gradients within a metrologically assessed scope.

4.2 Significance of the results from the biological point of view

A range of measurements proved that the product is suitable for equalization of such variations of the Earth's magnetic field of the natural scope (tenths of a microtesla). This characteristic is highly significant from a biological view point, as it returns the level of disturbance back to a biologically tolerable level.

This study examined the effect of the unit **on geopathic, but also technical disturbances.** Such disturbances of a magnetic field are particularly significant from the biological view point, especially in **populated places**. They also pose a significant burden in motor **vehicles** during longer or frequent drives.

4.3 Granting of the Seal

By means of objective physical measurement using magnetic induction meters we hereby proved the reliability and resistance of biologically beneficial effects (magnetic field equalization) of the Somavedic Medic Uran unit in its current version (crystal corpus). The tests conducted in compliance with the IIREC standard methods confirmed that the Somavedic Medic unit was suitable for the use in buildings (apartments, populated spaces) and in motor vehicles.

Owing to this evidence, all the requirements are met and the product can be granted the IIREC Seal. Provided that the below conditions and obligations are met, the producer/customer is entitled to mark the Somavedic Medic Uran product as "IIREC tested & certified" and stamp the product with the IIREC Seal:

Conditions:

(1) The seal validity must be renewed in time – before expiration.

(2) The IIREC shall be notified without undue delay of any change in the production

conditions or in the effects of the product.

(3) The use of the seal shall be suspended if an additional IIREC test shows that the product

quality no longer corresponds to the ascertained characteristics and/or any of the obligations is

not met.

Obligations:

(1) Product buyers must be provably instructed regarding the correct use of the product.

Important:

(1) The seal can be applied directly to the product, product documentation and product

packaging; as placed by the producer.

(2) Well ahead before the seal expires, the IIREC shall offer to the customer periodic

testing of the unit and if the result is positive, it shall renew validity of the seal.

(3) Upon request, the IIREC can draft additional quality assurance proposals.

(4) Preservation of the ascertained product quality shall be the responsibility of the

producer.
